As you will be aware from previous correspondence, we are instructed by Mr Christopher Boomer ('our Client') in relation to the protection of his intellectual property rights ('IPR') arising from games which are created and hosted on the Roblox platform.

The purpose of this letter is to notify you of content currently live on the Roblox platform which infringes our client's IPR and to request that the content is removed pursuant to the Digital Millennium Copyright Act 1998 ('DMCA').

Our Client has discovered the following game which is currently live on the Roblox platform and which infringes our Client's copyrighted work arising from his games, Weight Lifting Simulator 2, Weight Lifting Simulator 3 and Muscle Legends ('our Client's Games'):

The Infringing Game has blatantly taken artwork, code and assets from our Client's Games without the consent of our Client, who is the copyright holder.

You will note the Infringing Game was published by the group "Estatic Studios" (<u>https://www.roblox.com/groups/3116706/Estatic-Studios</u>). Estatic Studios previously published two other games which infringed our client's copyright in the Weight Lifting Simulator 3 game. These games were highlighted in previous DMCA requests issued by this firm to Roblox and were ultimately removed by Roblox as they were found to be infringing. These games were as follows:

You will note the Infringing Games set out above are receiving significant numbers of visits and are therefore generating significant revenues which are being redirected from our Client's games, thereby causing damage and loss to our Client.

It is quite clear from the above that the individual behind this group is deliberately targeting our Client's Games and is continuing to maliciously infringe our Client's copyright. The above conduct demonstrates that this User is a repeat infringer and is flagrantly breaching the Roblox Terms of Use. It is our view that such targeted and brazen infringement should also be considered grievous in accordance with Roblox's Intellectual Property Policy. We would therefore specifically request that this account is looked at in the context of Roblox's repeat/grievous infringement policy and guidelines.

We trust that, in accordance with the Roblox Terms of Use (specifically Section 6C subparagraphs 1-4) the Infringing Content will be removed from the Roblox platform immediately, and where necessary, the infringing User's account(s) will be disabled.

In accordance with the Roblox Terms of Use, we enclose a signed declaration confirming that our client is the copyright owner and that the use of our client's copyright for the above game has not been authorized by our client.
